Clinical theory occupies a problematic place in psychoanalysis since it offers generalised secondary process perspectives on what will always be unique manifestations of the encounter with the unconscious. Freud's technical papers exemplify some of the difficulties and these remain as relevant as they ever were. With reference to Freud's papers and to clinical work, my paper reconsiders issues of authority and mutuality, influence and autonomy, enactment and understanding in the light of contemporary analytic practice.
